ORDER:

Based on the report of the D.G., ACB, A.P, in reference 1st read above, disciplinary action was initiated against Sri P. Madhusudhana Rao, Architectural Draughtsman, O/o APCRDA, Vijayawada on the allegations of failure to obtain permission from the competent authority for acquisition/disposal of assets in reference 2nd read above.

- 2. In reference 3rd read above, Government appointed Sri Shaik Aleem Basha, Additional Commissioner, APCRDA, as an Inquiry Officer to inquire into the charges framed against Sri P. Madhusudhana Rao, Architectural Draughtsman, O/o APCRDA, Vijayawada. The Inquiry Officer conducted an inquiry and submitted his report, vide reference 5th read above.
- 3. In the reference 6th read above, Government have accepted the findings of the Inquiry Officer and communicated a copy of inquiry report to Sri P. Madhusudhana Rao, Architectural Draughtsman, O/o APCRDA, Vijayawada, with a direction to submit his written representations, if any, on the findings of the Inquiry Officer in terms of Rule 21 (2) of A.P.C.S. (CC & A) Rules, 1991 and the charged officer submitted his written representations requesting to drop further action against him, in reference 7th read above.

- 4. After careful examination of the matter and the AO's written representation, the Government have decided to impose the penalty of withholding one (1) annual grade increment without cumulative effect against Sri P. Madhusudhana Rao, Architectural Draughtsman, O/o APCRDA, Vijayawada as the charges held proved in the inquiry. Accordingly, the Government hereby imposes the penalty of withholding one (1) annual grade increment without cumulative effect against Sri P. Madhusudhana Rao, Architectural Draughtsman, O/o APCRDA, Vijayawada, with immediate effect.
- 5. The Commissioner, APCRDA, Vijayawada shall take necessary action in the matter accordingly.
