A list of documents and witnesses, by whom the articles of charges are proposed to be sustained, are also enclosed in Annexures-III & IV.
- 3. Sri P.V.K Bhaskar, the then Executive Engineer, Vijayawada Municipal Corporation (VMC), is directed to submit his written statement of defense within 15 days from the date of receipt of this order.
- 4. Sri P.V.K Bhaskar, the then Executive Engineer, Vijayawada Municipal Corporation (VMC), is informed that an inquiry will be held only in respect of those articles of charges that are not admitted. He should, therefore, specifically admit or deny each article of charge.
- 5. Sri P.V.K Bhaskar, the then Executive Engineer, Vijayawada Municipal Corporation (VMC), is further informed that if he does not submit his written statement of defence on or before the date specified in para 3 above, further action will be processed based on the material available.

Attention of Sri P.V.K Bhaskar, the then Executive Engineer, Vijayawada Municipal Corporation (VMC), is invited to Rule-24 of the Andhra Pradesh Civil Services (Conduct) Rules, 1964, under which no Government Servant shall bring or attempt to bring any political or outside influence to bear upon any superior authority to further his interest in respect of matters pertaining to his service under the Government. If any representation is received on his behalf from another person in respect of any matter dealt within these proceedings it will be presumed that above said Sri P.V.K Bhaskar, the then Executive Engineer, Vijayawada Municipal Corporation (VMC), is aware of such a representation and that it has been made at his instance and action will be taken against him for violation of Rule-24 of the Andhra Pradesh Civil Services (Conduct) Rules, 1964.
- 7. The Engineer-in-Chief, Public Health, A.P., Tadepalli, is requested to serve the charge memo to the charged officer along with copies of documents as per Annexure-III and furnish the dated acknowledgement. If dated acknowledgement is not received in the stipulated time, he is requested to propose for initiation of disciplinary action against the responsible official and furnish the draft articles of charges against them without any delay.
