ORDER:-

In the reference 1st read above, the Revenue (Ser.I) Department and in the reference 2nd read above, the Principal Chief Conservator Forest, AP, Hyderabad have placed the services of Sri Ravi Kumar, Joint Inspector General of Registration & Stamps Department and Sri R.Srinivasa Reddy, Assistant Conservator of Forest/DFO, Vig.II, respectively, at the disposal of the Municipal Administration & Urban Development Department as to work in connection with the Andhra Pradesh Capital Region Development Authority (APCRDA) on deputation basis initially for a period of one year.

The Pay and allowances of the above officers will be met from the annual budget of the Municipal Administration & Urban Development Department during the deputation period .

3. The Collector & District Magistrate, Guntur is requested to utilize the services of the above officers in connection with the work of the Andhra Pradesh Capital Region Development Authority only.

4. The Collector & District Magistrate, Guntur, the Commissioner, APCRDA., the Commissioner & Inspector General, (Registration & Stamps), A.P. Hyderabad and the Principal Chief Conservator Forest, AP, Hyderabad shall take necessary further action in the matter.
