## ORDER:-

Whereas in the reference 1st read above, the Vigilance & Department has brought to the notice to the Government that certain allegations of irregularities in Gudivada Municipality, against Sri N. Pramod Kumar, the then Commissioner, Gudivada Municipality and three(3) others on allegation of corruption activities in Gudivada Municipality and given NOC (Occupancy Certificate) to multistoried buildings thought they were constructed without proper setbacks & Solar Water supply facility and also allowed other buildings with many deviations.

2. Whereas in the reference 5<sup>th</sup> read above, Departmental action has been initiated against Sri S.V.S.U.B.Kameswari, then TPS & TPO (i/c), Gudivada Municipality and presently working as TPS, CRDA, and others, Gudivada Municipality for her failure that no attempts were made either to demolish or seize the violated portion of the houses of three independent buildings (at Sl.No. 1 to 3) during their construction resulting in irregular construction of houses but recommended to file charge sheet in the Hon'ble Court for the violations without any tangible ground work to remove the violations.

3. Whereas, in the reference 6<sup>th</sup> read above, S.V.S.U.B. Kameswari Town TPS, CRDA, has submitted her Written Statement of Defence stated that she has issued P.O.Notice and filed Charge Sheet in Hon'ble Court for 1<sup>st</sup> Building, in respect of second Building issued P.O.Notice for demolition whereas 3<sup>rd</sup> Building regularized under B.P.S as it is less than 100 Sq.Mts and requested to drop further action against her.

4. After careful examination of the matter and keeping in view of the written representation of the Charged Officer, Government hereby to drop further action against Smt S.V.S.U.B. Kameswari Town TPS, CRDA.

5. The Director of Town & Country Planning, AP, Gorantla, Guntur Shall take necessary action accordingly.
