ORDER:

In the reference 1st read above, Finance (Budget) Department, have issued Comprehensive Budget Release Order (CBRO) for the F.Y 2025-26 and allocated budget under the HoA "4217- Capital Outlay on Urban Development - 01 State Capital Development- 051 Construction – 03 Externally Aided Projects- 80 Amaravati Capital City Development Project – 530 Major Works - 531 Major Works" is Rs.6000,00,00,000.00/-.

2. In the reference 3rd read above, the Commissioner, APCRDA, Vijayawada has stated among others and requested to arrange funds to an extent of ₹1,000 crores to the PD account of APCRDA i.e. 8443001060104002002VN; 9211 deposit of loans from HUDCO to CRDA, DDO Code : 05151801001, which will be reimbursed soon after receipt of funds from NaBFID/APPFCL.

3. After careful examination, the Government hereby accord administrative sanction for release of an amount of Rs.1000,00,00,000.00/- (Rupees One thousand Crores Only) under the HoA "4217-01-051-03(Externally Aided projects)-80(Amaravati capital city development project)-530-531.

4. The concerned authority shall prepare Form-102 along with all relevant documents duly signed by the competent authority and to submit the same to the Concerned DDO for adjustment of the said amounts to enable to incur expenditure for implementation of the schemes.

5. The Assistant Secretary to Government (Drawing Officer), MA&UD Department, Andhra Pradesh, Velagapudi, shall draw the amount sanctioned in para (3) above and credit it to the APCRDA HUDCO PD Account No. 8443-00-106-01-04-002-002.

6. Further, the Commissioner, APCRDA is directed that as and when the loan amount of Rs.7500.00 Crore is received from NaBFID, this advance amount of Rs.1000.00 Crore has to be remitted to their EAP PD Account No.8443-00-106-03-04-002-001.
