## ORDER:

It is proposed to hold an inquiry against Sri Shaik Fazulur Rahman, the then Town Planning Officer, APCRDA, Vijayawada in accordance with the procedure laid down in Rule 20 of the Andhra Pradesh Civil Services (Classification, Control and Appeal) Rules, 1991.

- 2. The Articles of Charge, Statement of Imputations of misconduct / misbehaviour, List of Documents and List of Witnesses by which the charges are proposed to be sustained are enclosed as Annexures I, II, III & IV respectively.
- 3. Sri Shaik Fazulur Rahman is directed to submit his written statement of defence within 15 days from the date of receipt of this order.
- 4. Sri Shaik Fazulur Rahman is informed that an inquiry will be held only in respect of those Articles of Charge not admitted. He should, therefore, specifically admit or deny each Article of Charge.
- 5. Sri Shaik Fazulur Rahman is further informed that if he fails to submit the written statement of defence within the stipulated time, further action will be processed ex-parte on the basis of material available.
- 6. Attention of Sri Shaik Fazulur Rahman is invited to Rule 24 of the Andhra Pradesh Civil Services (Conduct) Rules, 1964, under which no Government servant shall bring or attempt to bring any political or outside influence to bear upon any superior authority to further his interests in respect of matters pertaining to his service. If any representation is received on his behalf from another person, it will be presumed that he is aware of such representation and that it has been made at his instance; action will be taken against him for violation of Rule 24.

7. The DTCP, AP is requested to serve the Charge Memo along with copies of all Annexures on the Charged Officer and furnish dated acknowledgement to this Department within 7 days. If acknowledgement is not received within the stipulated time, the DTCP shall propose initiation of disciplinary action against the responsible official and forward draft Articles of Charge without delay.
