5. That failure to join duty immediately on expiry of the leave period renders her liable for disciplinary action. If she does not return within the time, disciplinary action will be initiated;
6. That she should furnish her local leave address and service of any notice to the leave address will be deemed as service upon her. She will make adequate arrangements in her absence to authorize an appropriate person at the leave address to receive all letters / communications and make arrangements in her absence to have these communicated to her through any channel of communication.
7. That the individual does not have any involvement in court cases.
