**ORDER:**

Whereas, an inquiry under Rule 20 of the A.P. Civil Services (CC&A) Rules, 1991, is being held against Sri K.Venkateswara Rao, the then TPO, and Sri.K.Nagabhushanam, the then Municipal Assistant Engineer, Tenali Municipality on the allegations of corruption and misappropriation of public money in Tenali Municipality.

2. Whereas, Government after careful examination of the matter, it is considered that an Inquiring Authority should be appointed to inquire into the charges framed against above charged officers.

3. Now, therefore, in exercise of the powers conferred by sub-rule (2) of Rule-20 of A.P. Civil Services (CC&A) Rules, 1991, the disciplinary authority hereby appoint Sri P.V.K. Bhaskar, Superintending Engineer., APCRDA, Vijayawada as an Inquiring Authority to inquire into charges framed against the above charged officers.

4. The Inquiring Authority shall conduct the inquiry as per A.P.C.S.(CC&A) Rules, 1991 and submit his inquiry report to Government within a period of one month.
