ORDER:

In the G.O. 2nd read above, the services of Smt. D. Manorama, Deputy Collector, who was waiting for posting, have been placed at the disposal of MA&UD Dept., for being posted as Special Deputy Collector (LA)O/o/CRDA, Vijayawada Krishna dist., in relaxation of native district norms, on deputation basis, initially for a period of one year .Accordingly, Smt.
