ORDER:

Government have enacted the Andhra Pradesh Capital Region Development Authority Act, 2014 (Act. 11 of 2014) for establishment of the Capital for the State. Sub-Section (1) of Section 4 of the Act stipulates that (1) In accordance with the provisions of this Act, the State Government shall constitute a body to be called the Andhra Pradesh Capital Region Development Authority hereinafter called as the Authority for the capital region notified under section 3, which shall be a body corporate by the name aforesaid, having perpetual succession and a common seal, with power to acquire, hold and dispose of property, both movable and immovable and to contract and by the said name sue and be sued. Vide G.O.Ms.No.255, Municipal Administration & Urban Development (M2) Department, dated 30.12.2014 the Andhra Pradesh Capital Region Development Authority came into force.

2. The Andhra Pradesh Capital Region Development Authority serves entire State by housing the Capital City and Administrative Offices of the State Government. It is essential that the Andhra Pradesh Capital Region Development Authority has the necessary powers and duties of Head of department.
