**ORDER:**

Government in G.Os 1<sup>st</sup> and 2<sup>nd</sup> read above, have issued orders for staffing pattern to be followed in Andhra Pradesh Capital Region Development Authority and Andhra Pradesh Capital Region Development Authority Service Rules, 2015 respectively. Government in G.O 3<sup>rd</sup> read above have also issued selection procedure to be followed for recruitment of various posts in CRDA. The Government permitted the Commissioner, Capital Region Development Authority to engage School of Planning and Architecture (SPA), Vijayawada for conduct of the selections.

The Commissioner, Andhra Pradesh Capital Region Development Authority (APCRDA) in the reference 4<sup>th</sup> read above has informed that a meeting was held with Director, School of Planning & Architecture (SPA) and his team and also discussed the issue with Directors of CRDA and brought certain issues to the notice of Government.

The Government, after careful examination of the matter and in the light of the report submitted by the Commissioner, APCRDA, hereby permit the Commissioner, APCRDA to engage Andhra University and School of Planning and Architecture recruiting agency for CRDA and launch the recruitment process immediately for the sanctioned posts as required.

4. The Commissioner, Andhra Pradesh Capital Region Development Authority, Vijayawada, is informed that the other requests made by him are not agreed and he shall follow the APCRDA Service Rules, 2015 and the selection procedure.
