**ORDER**

As per the proposal of the Engineer-in-Chief (PH) in the reference 1<sup>st</sup> read above, the Departmental Promotion Committee has convened the DPC Meeting on 13.12.2016 and approved the panel for promotion to the post of Chief Engineer from the post of Superintending Engineer vide their proceedings 2<sup>nd</sup> read above.

**2.** Accordingly, in the reference 4<sup>th</sup> read above, orders were issued approving the list of eligible promotees for the panel year 2016-17, for promotion to the post of Chief Engineers in Public Health Department including the name of Sri T. Anjaneyulu, Superintending Engineer, APCRDA, Vijayawada (at serial No.2), but his promotion was deferred until termination of disciplinary proceedings pending against him (vide reference 3<sup>rd</sup> read above) in terms of orders issued in the G.O.Ms.No.424, GAD, dt.25.05.1976 read with G.O.Ms.No.257, GAD, dt.10.06.1999.

**3.** In the reference 5<sup>th</sup> read above, Government have dropped further action against Sri T. Anjaneyulu, Superintending Engineer, APCRDA, Vijayawada and exonerated from the charges as per rules.

**4.** In the reference 6<sup>th</sup> read above, the Engineer-in-Chief(PH) has requested the Government to consider the promotion of Sri T. Anjaneyulu, Superintending Engineer, APCRDA, Vijayawada as Chief Engineer w.e.f 23.01.2017 F.N. i.e., the date of joining of his immediate junior i.e., Sri R.Ankaiah, CE as per the approved panel communicated in the reference 4<sup>th</sup> read above and also requested the Government, on promotion, the individual may be posted as CE in APCRDA in the existing vacancy.

**5.** Government, after careful examination, hereby decided to consider the proposal of the Engineer-in-Chief (Public Health) and promote Sri T. Anjaneyulu, Superintending Engineer, APCRDA, Vijayawada as Chief Engineer in Public Health Department w.e.f 23.01.2017 F.N. (i.e., the date of joining of his immediate junior i.e., Sri R.Ankaiah, CE)., on ad-hoc basis under Rule 10 a (i) of A.P. State and Subordinate Service Rules, 1996. The promotion order is purely temporary and the same is subject to finalization of the seniority and court cases pending before the Hon'ble Courts if any. Consequent on promotion, the individual is posted as Chief Engineer in APCRDA, Vijayawada.

**6.** The Engineer-in-Chief (Public Health), Tadepalli, Guntur District shall take necessary action in the matter, accordingly.
