ORDER:

Whereas, it was brought to the notice of the Government that a case was registered in Cr.No.25/RCT-ACB-VJA/2015 U/s 7,12 & 13 (2) r/w 13 (1) (d) of the P.C. Act, 1988 of ACB, Vijayawada Range, Vijayawada against Sri Batlanki Sai Kumar, S/o Late Veeraswamy, 51 years, Architectural Draughtsman, Planning Section O/o Andhra Pradesh Capital Region Development Authority, Vijayawada, Krishna District was trapped on 16.11.2015 at 18.45 hours at KAPARDHI theatre, situated besides Sambamurthy Road, Gandhi Nagar, Vijayawada, when he demanded and accepted Rs.40,000/- as bribe from the complainant Sri Paruchuri Venkata Madhusudana Rao, S/o Dharma Rao, 49 years, R/o 11/138-D2-E6, Eluru Road, Guduwada, Krishna District. The A.O. was arrested on 16.11.2015 at 11.45 hours by the ACB officials and produced before the Hon'ble Special Judge for SPE and ACB Cases, Vijayawada on 17.11.2015 and he was remanded to judicial custody upto 01.12.2015.

2. Whereas, Government after careful examination of the matter, hereby order that the said Sri Batlanki Sai Kumar, Architectural Draughtsman, Planning Section, O/o Andhra Pradesh Capital Region Development Authority, Vijayawada, Krishna District is deemed to have been placed under suspension with effect from the date of his detention i.e., the 16-11-2015 in terms of Rule 8 (2) (a) of the Andhra Pradesh Civil Services (Classification, Control and Appeal) Rules, 1991 and shall remain under suspension until conclusion of all criminal / disciplinary proceedings.

3. Government further order that, during the period that this order remains in force Sri Batlanki Sai Kumar, Architectural Draughtsman, Planning Section O/o Andhra Pradesh Capital Region Development Authority, Vijayawada, Krishna District shall not leave the headquarters without obtaining the prior permission of the Government.

4. Government also order that during the period of suspension Sri Batlanki Sai Kumar, Architectural Draughtsman, Planning Section O/o Andhra Pradesh Capital Region Development Authority, Vijayawada, Krishna District shall be paid subsistence allowance as per rules in force.

5. The Commissioner, Andhra Pradesh Capital Region Development Authority shall take necessary action to file caveats in APAT/ APHC in order to prevent AO to obtain suspension order, without contesting by Government.
