He should, therefore, specifically admit or deny each article of charge.

Sri K.Srinivasa Rao, the then Deputy Executive Engineer, Tuni Municipality, East Godavari District, presently working as Executive Engineer in APCRDA, Vijayawada is further informed that if he does not submit his written statement of defence on or before the date specified in para 3 above further action will be processed based on the material available.

Attention of Sri K.Srinivasa Rao, the then Deputy Executive Engineer, Tuni Municipality, East Godavari District, presently working as Executive Engineer in APCRDA, Vijayawada is invited to Rule 24 of the Andhra Pradesh Civil Services (conduct) Rules, 1964, under which no Government Servant shall bring or attempt to bring any political or outside influence to bear upon any superior authority to further

his interest in respect of matters pertaining to his service under the Government. If any representation is received on his behalf from another person in respect of any matter dealt within these proceedings it will be presumed that above said Sri K.Srinivasa Rao, the then Deputy Executive Engineer, Tuni Municipality, East Godavari District, presently working as Executive Engineer in APCRDA, Vijayawada is aware of such a representation and that it has been made at his instance and action will be taken against him for violation of Rule-24 of the Andhra Pradesh Civil Services (Conduct) Rules, 1964.
