ORDER:

It is proposed to hold an enquiry against Smt. K. Lalitha, presently working as Deputy Collector, AP. CRDA., Guntur District, under Rule 24 of APCS (CC&A) Rules, 1991.

2. The substance of the imputations of misconduct or misbehavior in respect of which the inquiry is proposed to be held is set out in the enclosed statement of articles of charges (Annexure-I and II).

3. Smt. K. Lalitha, former MRO& MHO, Housing Rompicherla, now presently working as Deputy Collector, CRDA, Guntur, is directed to submit his written statement of defence within 10 days from the date of receipt of the memo.

4. Smt. K. Lalitha, the then MRO&MHO,Housing Rompicheral presently working as Deputy Collector, APCRDA, Guntur District, is informed that an enquiry will be held only in respect of those articles of charges as are not admitted. She should, therefore, specifically admit or deny each article of charge.

5. Smt. K. Lalitha, the then MRO&MHO, Housing Rompicheral presently working as Deputy Collector, APCRDA, Guntur District is further informed that if she does not submit his written statement of defence on or before the time specified in para-3 above, further action will be processed based on the material available.

6. Attention of Smt. K. Lalitha, the than MRO&MHO, Housing Rompicheral presently working as Deputy Collector, APCRDA, Guntur District, is invited to rule-24 of the Andhra Pradesh Civil Services (Conduct) Rules, 1964, under which no Government servant shall bring or attempt to bring any political or outside influence to bear upon any superior authority to further his interest in respect of matters pertaining to his service under the Government. If any representation is received on his behalf from another person in respect of any matter dealt with in these proceedings it will be presumed that Smt. K. Lalitha, the then MRO&MHO, Housing Rompicheral presently working as Deputy Collector, APCRDA, Guntur District, is aware of such representation and that it has been made at her instance and action will be taken against her for violation of rule 24 of the Andhra Pradesh Civil Services (Conduct) Rules, 1964.
