The Member of Service shall submit a report of his visit to the Government / Finance Department and mark a copy to the General Administration Department, Andhra Pradesh within one week soon after completion of the visit, specific with well-defined outputs of the visit that could be adopted for the State of Andhra Pradesh.

4. The G.A. (SC.A) Department is requested to make necessary in-charge arrangements for the post held by the above Member of Service during the above period.
