**ORDER**

As per the proposal made by the Engineer-in-Chief (PH) in the reference 1<sup>st</sup> read above, the Departmental Promotion Committee has convened the DPC Meeting on 14.12.2016 and approved the panel for promotion to the post of Superintending Engineer from the post of Executive Engineer vide their proceedings 2<sup>nd</sup> read above.

**2.** Accordingly, in the reference 4<sup>rd</sup> read above, orders were issued approving the list of eligible promotees for the panel year 2016-17 for promotion to the post of Superintending Engineers in Public Health Department including the name of Sri N.V.R.K. Prasad, Dy. SE(EE), PH QC Circle, Guntur (at serial No.5), but his promotion was deferred until termination of disciplinary proceedings pending against him (vide the reference 3<sup>rd</sup> read above) in terms of orders issued in the G.O.Ms.No.424, GAD, dt.25.05.1976 read with G.O.Ms.No.257, GAD, dt.10.06.1999.

**3.** In the reference 5<sup>th</sup> above, Government have dropped further action against Sri N.V.R.K. Prasad, Dy.SE (EE), PH QC Circle, Guntur and exonerated from the charges as the charges were held not proved in the enquiry.

**4.** In the reference 6<sup>th</sup> read above, the Engineer-in-Chief(PH) has requested the Government to consider the promotion of Sri N.V.R.K. Prasad, Dy.SE(EE), PH QC Circle, Guntur as Superintending Engineer w.e.f 04.01.2017 FN (i.e., the date of joining of immediate junior i.e., Sri N.Sivarami Reddy, SE as per the approved panel communicated in the reference 4<sup>th</sup> read above and also requested the government , on promotion, the individual may be posted as SE in APCRDA in the existing vacancy.

**5.** Government, after careful examination, hereby decided to consider the proposal of the Engineer-in-Chief (Public Health) and promote Sri N.V.R.K. Prasad, Dy.SE(EE), PH QC Circle, Guntur as Superintending Engineer in Public Health Department {w.e.f 04.01.2017 FN (i.e., the date of joining of immediate junior i.e., Sri N.Sivarami Reddy, SE)}. , under Rule 10 a (i) of A.P. State and Subordinate Service Rules, 1996 on ad-hoc basis. The promotion order is purely temporary and the same is subject finalization of the seniority and court cases pending before the Hon'ble Courts if any. Consequent on promotion, the individual is posted as Superintending Engineer in APCRDA.

**6.** The Engineer-in-Chief (Public Health), Tadepalli, Guntur District shall take necessary action in the matter, accordingly.
