Sub: Intimation Regarding Amaravati Capital City Development Plan in the state of Andhra Pradesh and Invitation for Reputed Bidders (National/International)

Amaravati aims to be a vibrant, diverse, and inclusive people's capital, synthesizing modern urban planning principles with sustainability, effective governance, and local cultural integration. Invitation to Register for the Bidding Process: To ensure the successful execution of these projects, we seek to engage with as many competent and experienced bidders as possible both at a national and global level. We kindly request interested bidders to:

- 1) Register as a contractor with the Government of Andhra Pradesh:** To participate in any tendering process in Andhra Pradesh:

- a) The contractors from other states of India and Firms of Foreign origin shall get themselves registered in A.P. state, under '**Special Class**' before offering their tenders for the said works. The registration of the "contractor" in A.P. state will be done by the Committee of Engineer-in-chief and the Commissioner, Commissionerate of Tenders, A.P., according to the eligibility criteria and guidelines as per G.O MS no. 94, G.O MS no. 130 and G.O MS no. 131 (copies enclosed as Annexure 1, 2 & 3) of the Irrigation & CAD Department, A.P Government. A checklist of the required documents for applying for registration of the contractor is also enclosed (Annexure 4) for the information of the interested contractors/firms.
- b) Any foreign firms interested to register with the A.P Government shall get the solvency, experience and other certificates attested by the Embassy of that country in India and shall also have to register its name in India as a Company/Agency as per the Indian Contract Law.

2) Register on the AP e-Procurement portal: This will allow the interested contractors to apply for the tenders issued by APCRDA through the online AP e-procurement portal.

3) Participate actively in the bidding process for the listed projects.

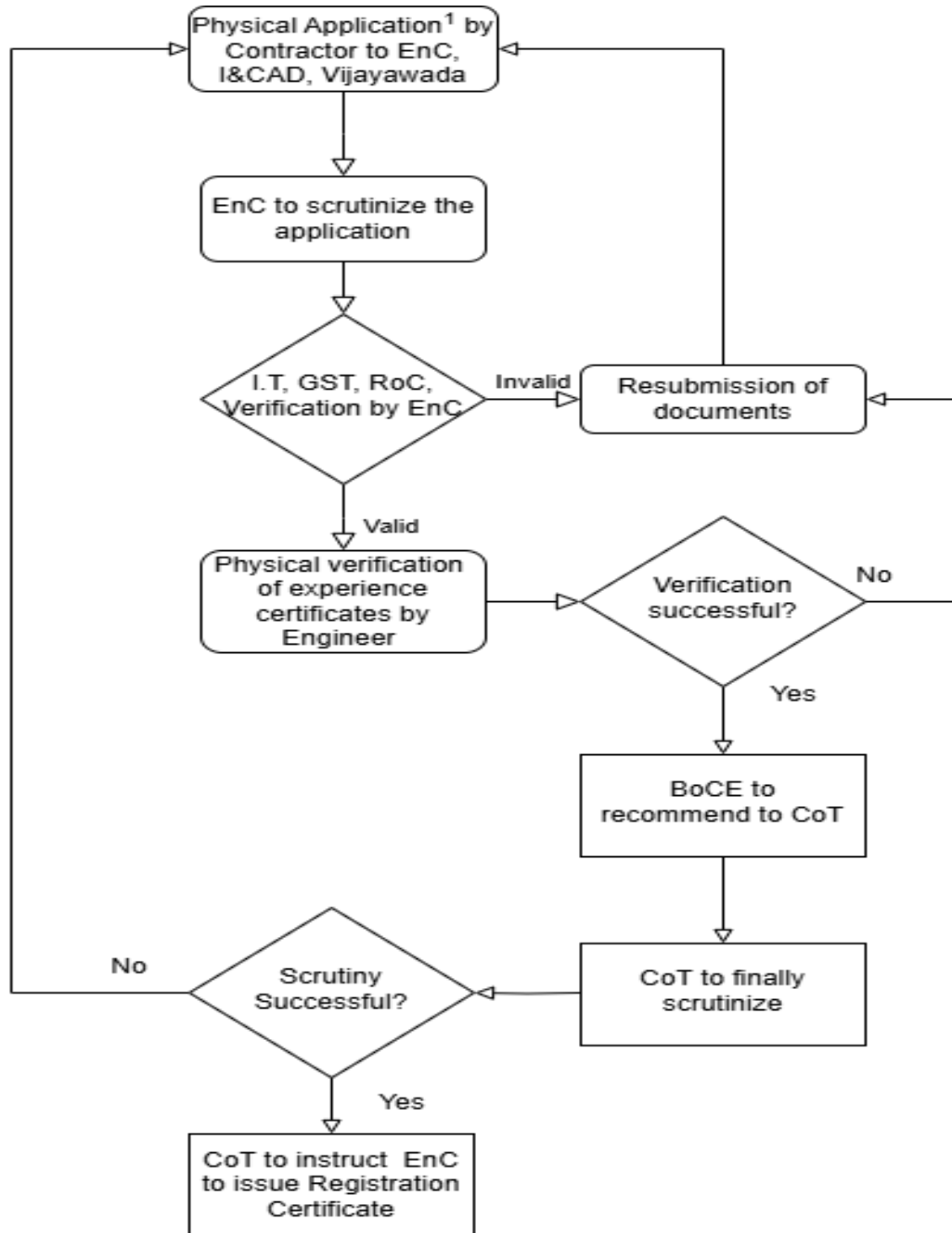

**PROCEDURE FOR REGISTRATION AS
A SPECIAL CLASS CONTRACTOR
WITH A.P. GOVERNMENT**

Step-by-step procedure

1. Any firm/contractor who intends to register as a Special Class Contractor in A.P. shall submit the below documents physically to the Engineer-in-Chief, Irrigation & CAD Department 4th Floor, Jalasoudha, Irrigation Compound, Musium Road, Vijayawada - 520 002.

2. After receiving the above application, the Engineer-in-chief (ENC) will scrutinize all the documents, cross-checking with the information available with other departments (Income Tax, GST, etc.)
3. To validate the experience in civil works, an engineer will physically approach and obtain a confirmation certificate from the concerned authority issuing such experience certificate to the applicant.
4. After completion of such required validation, the committee of Chief Engineers, headed by the ENC, will recommend the proposal for registration to the Commissionerate of Tenders (CoT), A.P., Vijayawada.
5. The CoT will scrutinize the proposal and upon an affirmative validation, permission will be accorded to the ENC for issuing the Special Class Registration Certificate to the Contractor.

The time required for the above process would be very minimal, if the documentation required is submitted by the applicant upfront.
