Agenda Item No. 1: Action Taken Report (ATR) of 4th CAC

The meeting commenced with a presentation on the Action Taken Report (ATR) covering the issues, raised during the previous meetings of the Citizen Advisory Committee. The concerned officers presented the status of action taken on each of the pending issues.

During the presentation the convenor has issued the following directions

1. Director (DP) to constitute 10 joint inspection teams comprising gram panchayat, APCRDA and revenue officials for field verification of encroachments and necessary action.
2. Engineering wing will be instructed to inspect and confirm quality of CIIP works in Inavolu and Dondapadu
3. Construction of Berm to R & B road near Yerrabalem ura tank has to be pursued on priority.
4. Concerned grid engineering wing will improve water supply pressure in Inavolu
5. Sanction memo of burial ground works are to be circulated to the CAC members.
6. Cube agency representative has to attend from next CAC meeting onwards
7. G.O related to road hit plots has to be circulated to CAC members.
8. Necessary action has to be taken for straightening the land allotted near VIT.
